Music and lyrics by Laurence O’Keefe and Nell Benjamin, book by Heather Hach; based on the novel by Amanda Brown and the Metro-Goldwyn-Mayer motion picture. *Legally Blonde, the Musical* is directed and choreographed by **Nick Sugar**, recently at Town Hall directing the 2016 production of *Violet* and the 2015 production of *West Side Story*. Nick is the winner of **Westword’s Best Director of a Musical 2015**. Musical direction is by **Donna Kolpan Debreceeni**, last seen music directing and leading the band at THAC for *Smokey Joe’s Cafe*. Donna is a **Henry Award Winner** for Town Hall’s 2012 production of *The Who’s Tommy*.

A fabulously fun international award-winning musical based on the adored movie, *Legally Blonde, the Musical* follows the transformation of Elle Woods as she tackles stereotypes, snobbery, and scandal in pursuit of her dreams.
